A Message from VP Dorothy Espelage

Happy Fall!

I am happy to report that the 2011 AERA Annual Meeting Division E program has come together nicely after a successful program meeting in Chicago. Now let's hope for excellent weather and attendance in New Orleans!

I have had mixed feelings about using this space to talk about the recent suicides linked to bullying and harassment directed toward sexual minority youth, but have decided to reach out to the Division E members so that we can all in our various roles do what changes were found for we can to minimize bullying.

First, as a scholar who has studied bullying for 17 years, it saddens me that parents, community members, and educators are surprised by the high rates of bullying in our schools. I want to assure you all that bullying is not increasing, but is not necessarily decreasing in our schools.

Second, suicidal ideation and attempts among sexual research community pay minority youth have not increased either; the media is exposing what we have been concerned with for some time. What is ignored in the press is the fact that only 5 of some 67 bullying prevention programs

discuss bullying directed at sexual minority youth.

Third, it is true that we need to examine more closely which school-based bullying prevention programs are being implemented in the US and whether they are empirically supported. Two recent meta-analyses indicate school-based programs have variable effectiveness:

Merrell et al. (2008) found positive effect sizes for only one-third of the study variables, which primarily reflected favorable changes in knowledge, attitudes, and perceptions of bullying. No bullying behaviors. Sixteen studies published from 1980-2004 were included in this meta-analysis.

Ttofi et al. (2008) in a report for the Swedish National Council for Crime Prevention evaluated 44 bullying intervention studies. Researchers noted that antibullying programs were more efficacious in smaller-scale European studies and less effective in the United States.

It is imperative that we as a close attention to these metaanalyses and modify existing programs to improve their potential impact. How might we do that?

To begin to answer this question, we must turn our attention to research and what has changed with respect to risk and protective factors of bullying involvement. Programs should consider the role of race/ethnicity, gender, and sexual orientation.

Programs also have to engage students through the use of media and attempt to shift peer norms and school climate factors that support bullying.

Programs also have to be easily implemented by teachers who are being asked to do some many other things in a day.

Well, hopefully, you would like to continue this conversation by attending two sessions at the 2011 AERA Annual Meeting on this very topic entitled:

Prevention of Bullying, Sexual Harassment, & Dating Violence Among Children & Adolescents:

School-based Bullying & Sexual Violence: Research on Gender-based Attitudes. Disability Status, & Sexual **Minority Youth**

Topic: Implicit-Explicit False Belief Understanding

Deadline: 12/1/2010

For this Special Issue in British Journal of Developmental Psychology (BJDP), researchers are invited to submit papers that explain early-late false belief understanding with reference to implicit-explicit knowledge systems.

Contributors may formulate their papers either by adopting the implicit-explicit knowledge distinction or by comparing alternative explanations with the implicit-explicit framework to explain early-late false belief understanding.

Both theoretical review papers and empirical studies will be considered.

This fall's Division E Program Meeting was held on September 23, 2010 at the University of Illinois Illini Center in Chicago. The 2011 Program Committee members are the program co-chairs (James and Paul) along with Dorothy Espelage, Vice- President, April Taylor, Affirmative Action Committee Representative, and Shadi Roshandel and Jioni Lewis, Graduate Student Representatives. This year Division E received 116 submissions (105 individual presentations, 11 symposia), which is slightly higher than last year's total (111). We were excited by the high quality and diversity of submissions. We found them to capture the broad scope of our fields and their relevance in educational contexts.

Division E will have 18 sessions closely aligned with the 2011 AERA convention theme Inciting the Social Imagination: Education Research for the Public Good. These include symposia (6), paper sessions (5), poster sessions (3), round tables (2), and a structured poster session (1). Titles for select sessions include:

- Language and Literacy Development in Diverse Settings;
- Measurement of Social and Behavioral Skills from Birth Through Adolescence: Implications for Educational Research;
- Positive Growth and Development: Programs in Coping;
- Prevention of Bullying, Sexual Harassment, and Dating Violence Among Children & Adolescents:
- Problematic Adolescent Behavior Across Contexts;
- Promoting and Sustaining Math Self-Efficacy;
- Research On Linking The Moral, Social And Political In Human Development;
- School-based Bullying and Sexual Violence Perpetration/Victimization: Research on Gender-based Attitudes, Disability Status, & Sexual Minority Youth;
- Thinking Outside the Box: Which Student Supports are Necessary in High Expectation High Need Schools?

This was the second year that AERA has employed reviewer panels composed of volunteer experts.

We whole-heartedly thank those who served as reviewers. Your work is so very important to ensuring a high-quality program. 

Affirmative Action

Greetings Division E Members,

This year the American **Educational Research** Association (AERA) held its annual Coordinated Committee Meeting (CCM) on October 29-30 at the **Hyatt Regency Washington** on Capitol Hill. President Kris Gutierrez chaired the event. The CCM marks the annual gathering of AERA's elected, appointed, and executive leadership to provide a forum and opportunity for crosscommittee and -council discussions.

This year's Coordinated Committee Meeting was preceded by the 7th Annual *Brown* Lecture, featuring Professor Kenji Hakuta, Lee J. Jacks Professor of Education, Stanford University School of Education.

The agenda for the Affirmative Action Council (AAC) in particular included reports from each Division's AAO, and joint meetings with the Division Vice Presidents, the Social Justice Action Committee, the Scholars of Color in Education Committee, and the Scholars & Advocates for Gender Equity in Education Committee.

Topics of discussion were varied and included, 1) engendering vertical and

horizontal participation and collaboration within AERA, 2) effective communication of shared interests across the membership and entities, 3) expanding AERA's demographic identifiers (i.e., adding transgendered), and 4) a policy for the treatment of non-blind submissions.

As for Division E's upcoming program, we had a slight increase in submissions compared to the previous year [N = 105 individual submissions (papers or posters) and N = 10 symposium submissions, approximately equally divided between the two subdivisions]. Acceptance rates for Human Development and Counseling were 63.6% and 62% respectively for papers and 50% for symposia.

Of the proposals accepted, a majority dealt with issues of diversity including topics/populations including, but not limited to, the achievement gap, bullying/victimization, disability, sexual minorities, first-generation college students, ethnic-minorities, single parents, international students, and generally marginalized groups.

Nominations for this category will be accepted for dissertations completed during the years 2008, 2009, and 2010.

Nomination materials should include two electronic copies of an article-length manuscript from the dissertation with personal information removed from one of the copies. Full length dissertations will not be accepted. Nominations must also include a letter of nomination from the dissertation chair and verification that the nominee is currently a Division E Member. Manuscripts may or may not have been published.

Distinguished Research Award

Nominations for this category will be accepted for journal articles or book chapters published during 2008, 2009, 2010. Self-nominations for these awards are encouraged.

Nomination materials must include an electronic copy of the publication and a nominating letter indicating the unique and important contribution of the study to the literature along with verification that at least one of the authors is a current Division E member.

Each award recipient will receive a plaque and a monetary award, to be presented at the 2011 AERA Annual Meeting Division E business meeting. Nominations must be received no later than **December 15, 2010** to be considered for the 2011 competition.
